**IMPORTANT!** \$35 fee is applied to complete enrollment in Homebuyer Readiness. \$35 fee is waived for households at 100% Federal Poverty Level and who state cannot afford fee. \$20 fee is applied to pull a Tri-Merged Credit Report at counseling appointment. \$20 fee is waived for Foreclosure Prevention clients, Lender-Referral eHome clients, and for households with income below 50% Area-Median-Income. \$99 fee is applied for eHome America. FSS, KTO, Bronson HOP, City HOPE, USDA Direct, KNHS DPA, HomeTown, and VA loan clients are eligible for \$50 eHome coupon. \$150 fee is applied for Section 32 Homebuyer Education & Counseling; this \$150 fee is waived if client completes eHome America or reduced if completed Homebuyer Readiness. Homebuyer Readiness fees are collected at time of enrollment. Credit Report fees are collected at first counseling appointment. **NO CASH or advanced payments.** **Only** checks, money orders or PayPal are accepted. KNHS cannot offer refund after payment has been applied.
